**Opportunity 1: 31 March 2021**, submission 30 June 2021

**Opportunity 2: 30 June 2021**, submission 30 Sept 2021

**Opportunity 3: 30 Sept 2021**, submission 30 Dec 2021

- A grace period of 3 days after the cut-off date to submit articles is approved. Members can still submit articles within this timeframe but must pay a 50% fine of the article opportunity's original price.
