Finance

SAPIK's funds are healthy and shows steady and healthy growth both in SAPIK's liquidity and savings account.

We transferred 39% of our surplus over into our liquidity account and later in 2022 another percentage will be transferred into the liquidity account in order to receive more rent income on the liquidity account.

Funds are also allocated for our 2022 business savvy taking place this year.

Members are welcome to inform the SAPIK administrative office at any point if training in newly bought test batteries is needed. The administrator will compile a list and members will be notified when training will take place.

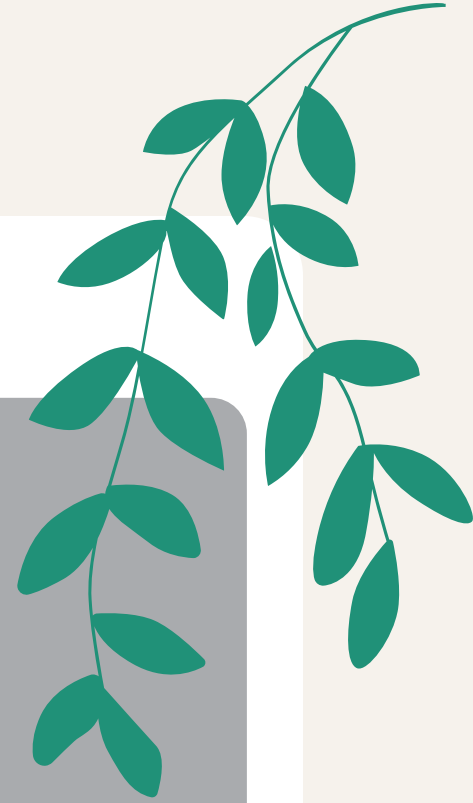

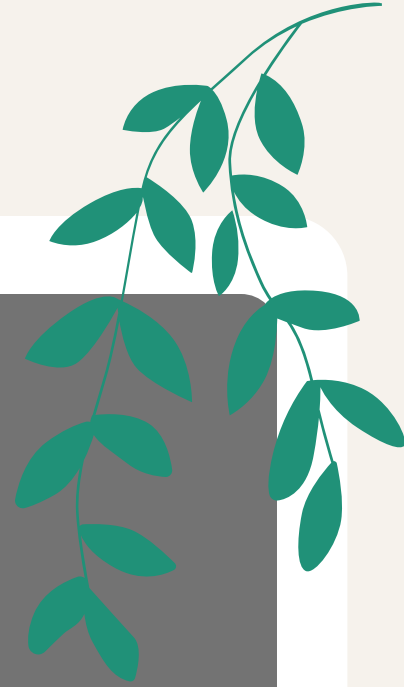
Ethical Article Opportunity
